General Rules for all contestants

She must live in Mercer County, PA

She will be judged on neatness, originality, personality and a question's answer.

She will receive a Crown and Sash which she will be requested to wear throughout the Fair Week.

She will ride in this year's Parade

General Rules for Miss Transfer Harvest Home

She must be at least age 16, but no older than 20, years of age as of June 1, 2022

She will also be judged on a personal interview

She will ride in this year's Parade and attend at least 2 other evenings at the fair.

She will represent Transfer Harvest Home Fair in at least 2 other parades before next year's contest.

She will crown the next year's queen.

Available to attend State Fair Queen competition (if Covid restrictions allow event to occur)

Business Casual will be required for the interview and formal gown for the pageant.

General Rules for Junior Miss Transfer Harvest Home

She must live in Mercer County and be 12 to 15 years of age as of June 1, 2022

Formal dress will be required for pageant (Short is ok, must be appropriate length to sit on stage)

General Rules for Little Miss Transfer Harvest Home

She must live in Mercer County and be 8 to 11 years of age as of June 1, 2022

Formal dress will be required for pageant (Short is ok, must be appropriate length to sit on stage)

Miss Transfer Harvest Home contest will consist of 3 sections:

1. Personal Interview – Each contestant will meet with a panel of three judges. The interview is judged on conversational ability, answers to a variety of questions, appearance/poise, and knowledge of the Transfer Harvest Home.
Please arrive at 6pm for the interview time slot.
2. Formal Gown / Introduction – this segment is conducted in front of the three judges and any general public that wish to attend. Each contestant will walk on stage and introduce herself to the audience. This event is judged on content, stage presence and appearance. Small introduction should include name, where they are from and/school and grade. (Less than 1 min)
3. Impromptu Question - Each contestant will be required to answer 1 question randomly selected from a pool of questions in front of the judges and audience. Fair & Community Related

Junior Miss Transfer Harvest Home contest will consist of 2 sections:

1. Formal Gown / Introduction – this segment is conducted in front of the three judges and any general public that wish to attend. Each contestant will walk on stage and introduce herself to the audience. This event is judged on content, stage presence and appearance. Small introduction should include name, where they are from and/school and grade. (Less than 1 min)
2. Impromptu Question - Each contestant will be required to answer 1 question randomly selected from a pool of questions in front of the judges and audience. Fair & Community Related

Little Miss Transfer Harvest Home contest will consist of 2 sections:

1. Formal Gown / Introduction – this segment is conducted in front of the three judges and any general public that wish to attend. Each contestant will walk on stage and introduce herself to the audience. This event is judged on content, stage presence and appearance. Small introduction should include name, where they are from and/school and grade. (Less than 1 min)
2. Question - Each contestant will be required to answer 1 question provided at registration that is Fair & Community Related

Miss Transfer Harvest Home and Jr Miss Harvest Home Dress Code:

Wearing of the Miss Transfer Harvest Home crown and/or sash is to be considered an honor and privilege. The bearer represents herself, her family, her community and fair. Therefore, professional appearance is expected while in crown and sash:

1. Attire that is conducive to the specific appearance or event (i.e. business casual, formal, etc.)
2. Shorts and skirts must be appropriate length (longer than fingertip length)
3. Business casual tops must not be strapless or spaghetti strap, wide strap sleeveless is acceptable.
4. No outfit that is too low cut, too short or too revealing. No exposed midriff.
5. No visible piercings (other than earrings) or tattoos.
6. No clothing that advertises, promotes, or glorifies the use of profanity, alcohol, tobacco, drugs, or anything inconsistent with the dignity of the Miss Transfer Harvest Home Program.

Miss Transfer Harvest Home and Jr Miss Harvest Home Behavior Policy:

The Contest's governing Board shall have the sole discretion to determine whether, in its judgment, any contestant may continue to participate in the Program, in the event that Board determines that any statement or representation is not true and accurate, or that any action is inconsistent with the rules, standards and dignity of the Program.

The following will be considered violations of the Policy and will be grounds for immediate disqualification, dismissal and/or being banned from future Queen competitions:

1. Any infractions of any pageant Contest rules.
2. Smoking/Vaping, foul language and/or public displays of affection to dates/boyfriends while wearing crown and/or sash and representing the Miss Transfer Harvest Home Program.
3. Engagement in any illegal, unpartisan, unethical, indecent and/or morally questionable behavior, including but not limited to online representations on the Internet such as social networking sites (Facebook, etc.)
4. Use of any illegal controlled dangerous substances or abusing the use of alcohol or other dangerous substances.
5. Any defamation of the Miss Transfer Harvest Home Contest, its winners and contestants, and the Fair or the PA Fair Queen Program and their Directors and Committee members, whether it be oral or written. This includes postings on the Internet.
6. Any uncooperative or unsportsmanlike conduct before, during or after the competition.
